Workshop location

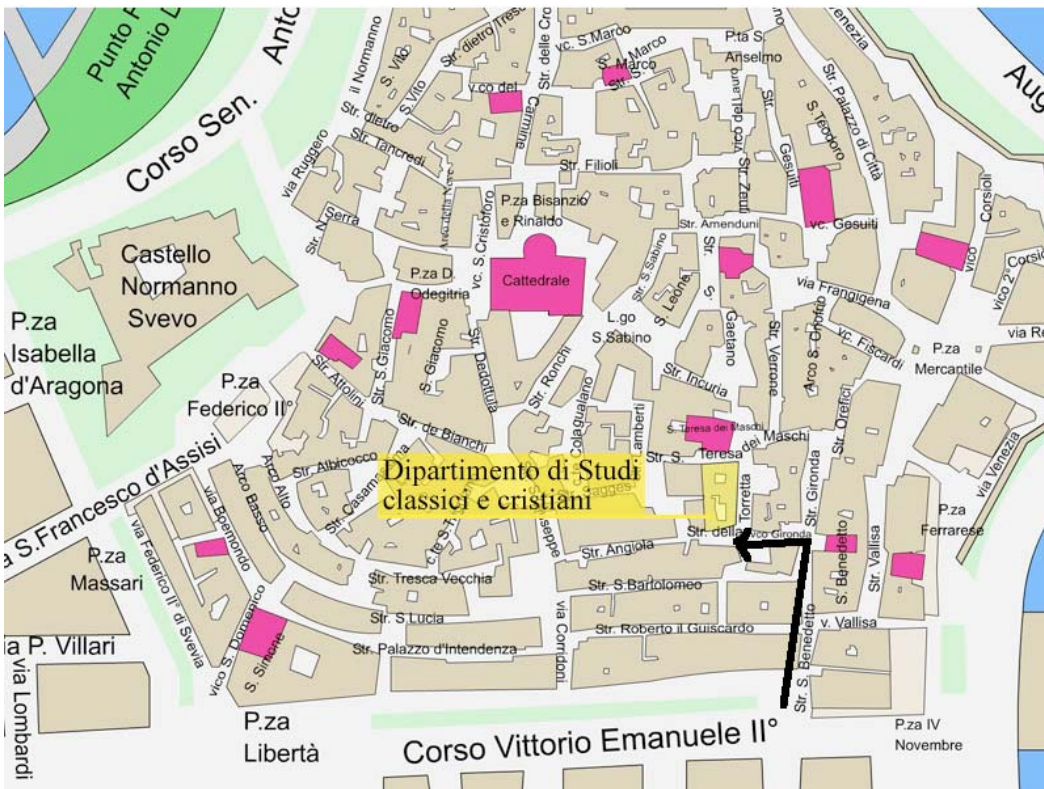
