## STRUCTURE

The minor has been structured to provide academic rigor combined with high flexibility, to better suit the unique needs of each student. It consists of:

1. BUS 305 Introduction to Entrepreneurship (*Junior Standing*)
2. Four elective courses with strong relevance for would-be entrepreneurs, to be recommended by the Director of the JCU Institute for Entrepreneurship and approved by the student's Advisor.
3. MGT 410 Entrepreneurial Management (*Junior standing. Pre-requisites: BUS 305. Recommended for business students: FIN 301, MGT 301, MKT 301*)

The elective courses (see indicative list on the back) shall meet the following criteria:

- a. They provide specific business tools and/or insight in the student's field of interest.
- b. Together with the two mandatory courses, they create a logical progression that will provide the student the necessary tools to achieve his/her objectives.

## WHO CAN REGISTER FOR THE MINOR

Any student in good standing with a strong interest in entrepreneurship can register for the minor, regardless of the major. Non-business students will receive the necessary basic quantitative training during the first course, BUS 305 Introduction to Entrepreneurship.

## HOW TO REGISTER FOR THE MINOR:

1. Make an appointment with the Director of the JCU Institute for Entrepreneurship (IFE).
2. Download the Minor for Entrepreneurship Form from the Intranet and explain why you wish to complete a minor in Entrepreneurship and how you think it will help you achieve your professional goals.
3. Meet with the Director of IFE, taking the form with you; the Director will recommend a selection of courses and the optimal sequence based on your objectives and joint discussion.
4. Make an appointment with your Advisor to review the above recommendations. Your advisor may further refine the selection together with the IFE Director.
5. Once your Advisor has signed off on the form, take it to the Registrar to register for the program.

## FOR ADVISORS – HOW DOES THE COLLABORATION WORK?

The main objective of the minor is to maintain flexibility while preserving academic integrity. the Director of IFE will make a recommendation based on the student's objectives and his/her understanding of how best to achieve them, but the Advisor will have the final say, maintaining control of the advising process.
